3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Porchlight Nakoosa Trail HUD Program has been in existence since January of 2013. We have a total of three newly constructed HUD efficiency units. The target population is individuals who meet the HUD definition of chronically homeless. Residents are selected from the top of the Community Wide Prioritization list. The three residents are offered case management from a Porchlight case manager. This case manager provides transportation to medical appointments, grocery stores and food pantries, as well as any other appointments as needed. All services are documented in WI ServicePoint. The case manager also provides support with mental health issues such as hoarding and collecting behaviors, anxiety, and depression. Residents are provided a monthly bus pass.

The population being served is chronically homeless individuals, many of whom have spent significant time both in shelter and on the street. Many residents have mental health issues, substance abuse issues, or both. The goal of supportive services for PSH residents is to provide them with the overall support structure necessary to help them maintain safe, affordable housing and improve their self-sufficiency. Frequency and intensity of case management services vary based on individual need and desire. PSH case managers provide an array of services tailored to each resident, which may include budgeting, job skills training, advocacy and system navigation, housing application, and referral to benefits and resources in the community. The residents and case managers may work together to identify previous and potential barriers to maintaining permanent housing, and establish supports so the clients are able to succeed in housing long-term.

Residents may elect not to participate in supportive services, but the case managers will continually attempt to engage with all clients. Residents are offered the opportunity to develop an Individual Service Plan (ISP) that incorporates both short- and long-term goals that they identify. The case managers are trained in Housing First approaches, harm reduction, and motivational interviewing, which helps them to provide the best support to their clients.

Projected Outcomes:

- 80% or more of participants remain stable in PSH for at least one year or exit to a different permanent housing situation
- 75% of participants will maintain or increase their total income


